- Storage of cytotoxic drugs (against cancer) in landfills can cause groundwater contamination.
- Expired drugs destruction in non-specialized plants causes sustainable air contamination. Cytotoxic substances in the air and water have several known negative health effects (source: OMS):
- Cytotoxic substances action is not selective: they attack all cells, even healthy cells (renal and

Outdated drugs have been found on parallel markets disturbing pharmacists by introducing illegal competition.

- Purchase of drugs in those illegal channels may cause significant risks to consumer's health. - Expired drugs trafficking goes beyond borders. According to the International Federation of the medicine industries, illegal drug trade is potentially far more profitable than heroin trade.

- This traffic if uncontrolled can become a source of discord between distributors and manufacturers and can cause difficulties in Quality System Management.



### A - We know local and international regulations.

 Movements of wastes between countries are regulated by the Basel Convention of March 22<sup>nd</sup>, 1989. All wastes imported into Europe to be destroyed must be authorized by all impacted countries (importer / exporter and transit countries).

• The authorization process is led by RECYCLAMED experts who have over 10 years of experience in this field.


• All wastes movements to destruction facilities have to scrupulously follow the processes dictated by Regulation (EC) No 1013/2006 of the European Parliament and of the Council of June 14<sup>th</sup>, 2006 amended by regulations (EC) n° 1379/2007 of November 26<sup>th</sup>, 2007 and no. 308/2009 April 15<sup>th</sup>, 2009.

- Validation / witness is made by RECYCLAMED auditor, on site, in order to validate the Bill of Loading conformity.
- RECYCLAMED supplies carrier all legal documents for customs controls.
- RECYCLAMED informs producer/client about all steps, up to destruction.






### **Secure destruction**

• 3 working days after destruction, RECYCLAMED supplies official EU and Basel Convention proof of destruction to producer/customer.

• A clearance process can be needed, if declared shipment before departure is different after reception.





### **C** - Offences in case of illegal transfer of rejected pharmaceutics.

### Persons found guilty of the following offences may be subject to a financial sentence and years of imprisonment :

A Carrying out, or having another party carry out, a movement of waste without having notified the competent authorities, or without having received prior approval from authorities.

**A**...for which the approval of competent authorities was obtained fraudulently.

- A...carry out a movement of waste of a different nature to the one indicated in the notification and movement documents stipulated by Article 4 of the Regulation cited above, or involving a quantity of waste that is significantly
